BASE RATE AREA MAP

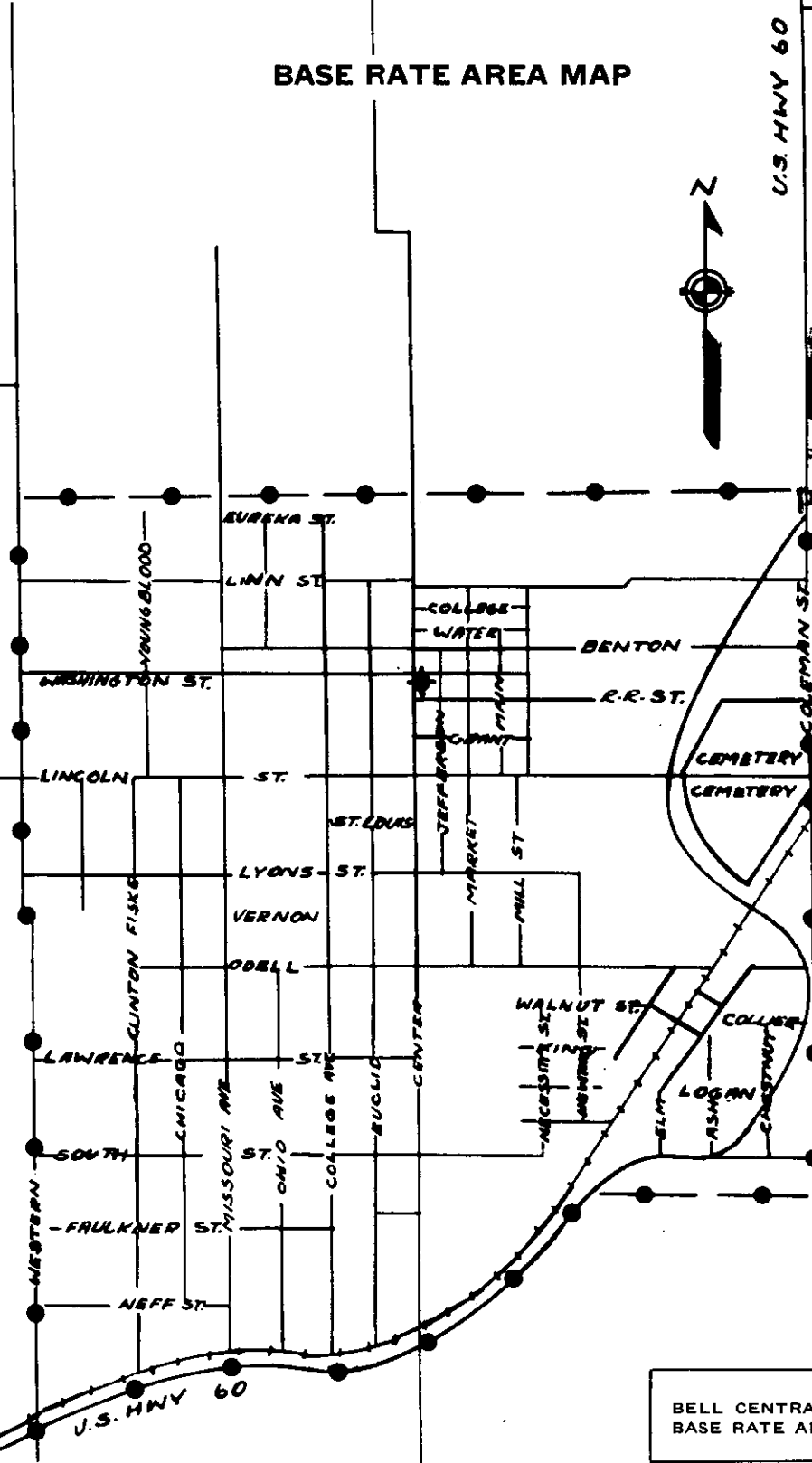
