SECOND REQUEST FOR EXTENSION OF TIME

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), through Staff Counsel’s Office, and for its *Second Request for Extension of Time*, states as follows:

1. On April 9, 2021, Osage Valley Electric Cooperative (Osage Valley) and Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed a *Joint Motion for Approval of a Third Addendum*.
2. On April 12, 2021, the Commission issued its *Order Directing Notice, Setting Intervention Deadline, and Directing Staff Recommendation*. The *Order* directed Staff to file a recommendation regarding the *Joint Motion for Approval of a Third Addendum* no later than May 12, 2021.
3. On May 12, Staff requested a one week extension to file its recommendation. The Commission granted Staff’s request on May 13, 2021.
4. During the course of its review, Staff noted the owner of record for the parcel described in the Third Addendum has changed. Due to changes in ownership and the size of the parcel at issue in the Third Addendum, Staff cannot file a recommendation until an amended application or clarifying motion is filed by the Applicants.

5. Following a conversation with Staff, Applicants filed earlier today a Joint Motion to Clarify regarding changes to the parcel at issue in the Third Amended Territorial Agreement.

6. Staff requests a two week extension of time, to June 2, 2021, to file its recommendation on the Joint Application as amended by the Joint Motion to Clarify, but it will file the recommendation sooner if possible.

WHEREFORE, Staff prays that the Commission will grant it until June 2, 2021 to file its recommendation on the Joint Application as amended by the Joint Motion to Clarify; and such other and further relief as the Commission deems just in these circumstances.
