ORDER UPDATING TRACKING NUMBER FOR STAFF RECOMMENDATION AND OTHER RESPONSES

On November 4, 2024, Liberty Utilities (Midstates Natural Gas) Corp d/b/a Liberty filed three tariff sheets, Sheet 62, 63, and 65 (P.S.C. No. 2) to reflect changes in the company's Purchased Gas Adjustment clause and Actual Cost Adjustment and Refund Factor. Those tariff sheets were assigned Tracking No. JG-2025-0064 with an effective date of December 1, 2024.

On November 5, 2024, Liberty withdrew Tracking No. JG-2025-0064 and filed a tariff sheet, Sheet 44 (P.S.C. No. 2) assigned Tracking No. JG-2025-0065. The tariff sheet has an effective date of December 1, 2024.

On November 8, 2024, Liberty withdrew Tracking No. JG-2025-0065, and submitted Tracking No. JG-2025-0073. The tariff sheet, Sheet 44, was submitted due to an error noted by the Staff of the Public Service Commission (Staff). The tariff sheet has an effective date of December 1, 2024.

The Commission will update its prior order regarding Tracking No. JG-2025-0065 and will direct the Staff to file a recommendation regarding Tracking No. JG-2025-0073. The Commission will also update its direction for other entities to file a response to

Tracking No. JG-2025-0073. Both deadlines will remain November 14 as set forth in the Commission's prior order.

THE COMMISSION ORDERS THAT:

1. No later than November 14, 2024, Staff shall file a recommendation with regard to Tracking No. JG-2025-0073.
2. Any other entity wanting to comment on Tracking No. JG-2025-0073 shall do so no later than November 14, 2024.
3. This order shall be effective when issued.
