ORDER APPROVING PURCHASED GAS ADJUSTMENT TARIFF

Issue Date: November 12, 2024

Effective Date: November 15, 2024

On October 31, 2024,¹ Spire Missouri Inc. d/b/a Spire filed revised tariff sheets to reflect changes in the company's Current Purchased Gas Adjustment (CPGA) factors as a result of estimated changes in the cost of natural gas in its eastern Missouri operating division (Spire East) and its western Missouri operating division (Spire West). Also included in the filing is the annual change to the Actual Cost Adjustment (ACA). The tariff sheets bear an effective date of November 15 and were assigned Tracking No. JG-2025-0060. On November 1, Spire filed a substitute tariff sheet for Spire East to correct an error in the original filed ACA rate.

Spire's proposed PGA tariff sheets will have the following effects on its PGA rates per centum cubic feet (Ccf):

Operating Division	Current PGA	New Total PGA	Difference
East	\$0.77588	\$0.52486	-\$0.25102
West	\$0.91988	\$0.62139	-\$0.29849

¹ Unless otherwise noted, all dates refer to the year 2024.

In the October 31st cover letter filed with the revised tariff sheets, Spire states that the decreases are due to “lower gas prices and recovering the majority of the deferred costs of Winter Storm Uri.”

On November 1, the Commission directed that, no later than November 7, the Staff of the Commission (Staff) file a recommendation and that any other comments or recommendations concerning the tariff sheets be filed no later than by November 8. Staff filed its recommendation on November 6. No other party filed a response.

Staff recommends that the tariff sheets be approved on an interim basis, subject to refund, and pending final Commission decisions in this file and ACA File No. GR-2023-0217. Staff also asked the Commission to order it to file the results of its ACA review in this case no later than December 15, 2025.

The Commission has reviewed the proposed tariff sheet and Staff’s recommendation. The Commission finds that the proposed tariff sheets conform to Spire’s Commission-approved PGA clause. Given that Spire’s PGA clause allows for PGA change filings to take effect after ten business days’ notice, good cause has been shown pursuant to Section 393.140(11), RSMo 2016, to permit the tariff sheets to become effective on less than 30 days’ notice. Thus, the Commission finds it reasonable for this order to be effective in less than 30 days so that the order will be effective at the same time as the tariff.

THE COMMISSION ORDERS THAT:

1. The tariff sheets, assigned Tracking No. JG-2025-0060, are approved on an interim basis and subject to refund, pending final Commission decisions in this file and in File No. GR-2023-0217. The tariff sheets approved are:

Fourth Revised Sheet No. 11.7, Cancelling Third Revised Sheet No. 11.7 (East)
Fifth Revised Sheet No. 11.8, Cancelling Fourth Revised Sheet No. 11.8 (West)

2. On or before December 15, 2025, Staff's Procurement Analysis Department shall submit the results of its ACA review.

3. This order shall become effective on November 15, 2024.

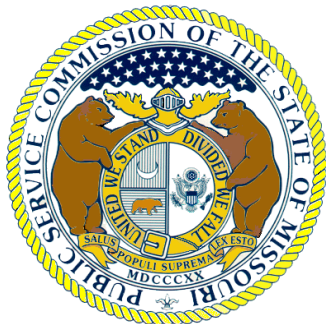
