ORDER SETTING DISCOVERY CONFERENCE

On November 12, 2024, counsel for the Office of the Public Counsel (OPC) contacted, via e-mail, the presiding officer in this matter to make him aware of a discovery dispute between OPC and Missouri-American Water Company. OPC states that the two parties have conferred by telephone but have not resolved the dispute. OPC requests a telephone conference with the presiding officer and opposing counsel pursuant to Commission Rule 20 CSR 4240-2.090(8)(B) at a date and time agreed upon by the two parties. Counsel for OPC notes that the issue was not brought to his attention until after the last scheduled discovery conference and that no other discovery conferences are scheduled prior to the December 6, 2024, deadline to file direct and rebuttal testimony.

The Commission will grant OPC’s request and schedule a conference.

THE COMMISSION ORDERS THAT:

1. A discovery conference will be held on Wednesday, November 13, 2024, at 11:00 a.m. via WebEx phone and video. Login details will be e-mailed to the parties prior to the conference.
2. This order shall be effective when issued.
