ORDER DIRECTING STAFF TO FILE RECOMMENDATION

On November 8, 2024, Missouri-American Water Company (MAWC) submitted an application requesting authorization to issue long-term debt in the amount up to \$525.0 million.

MAWC also requested waiver of the 60-day notice requirement under Commission Rule 20 CSR 4240-4.017.

The Commission will direct the Staff of the Commission (Staff) to file a Recommendation regarding MAWC's application or a status report addressing when it expects to file the Recommendation.

THE COMMISSION ORDERS THAT:

1. No later than December 5, 2024, Staff shall file a Recommendation or a status report regarding when it expects to file its Recommendation.
2. This order shall be effective when issued.
