On October 28, 2021, the Staff of the Missouri Public Service Commission (Staff) filed its recommendation following its first prudence review of Cycle 3 costs related to the Missouri Energy Efficiency Investment Act and Cycle 2 long-lead projects for the electric operations for the period January 1, 2020, through March 31, 2021. Staff identified and recommended certain disallowances or adjustments. On November 2, 2021, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy West) filed a Request for Hearing. Evergy West disputed Staff's disallowances and asked the Commission to set a prehearing conference so that the parties can develop a recommended procedural schedule. The Commission requests the parties address the following items as part of the procedural schedule:

- Position Statements at least one week prior to the evidentiary hearing
- Order of Hearing Components

- An evidentiary hearing to be held via WebEx
- Briefing Schedule
- Whether files EO-2021-0416 and EO-2021-0417 should be heard on a common record
