ORDER DIRECTING JOINT PROPOSED SCHEDULE

On October 28, 2021, the Staff of the Missouri Public Service Commission (Staff) filed its recommendation following its first prudence review of Cycle 3 costs related to the Missouri Energy Efficiency Investment Act and Cycle 2 long-lead projects for the electric operations for the period January 1, 2020, through March 31, 2021. Staff identified and recommended certain disallowances or adjustments. On November 2, 2021, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy West) filed a Request for Hearing. Evergy West disputed Staff's disallowances and asked the Commission to set a prehearing conference so that the parties can develop a recommended procedural schedule. The Commission will direct the parties to jointly propose a procedural schedule. The Commission requests the parties address the following items as part of the procedural schedule:

- Pre-filed testimony
- Joint Stipulation of Facts
- List of Issues
- Position Statements at least one week prior to the evidentiary hearing
- Order of Hearing Components

- An evidentiary hearing to be held via WebEx
- Briefing Schedule
- Whether files EO-2021-0416 and EO-2021-0417 should be heard on a common record

THE COMMISSION ORDERS THAT:

1. No later than November 18, 2021, the parties shall submit a joint proposed procedural schedule as described in the body of this order.
2. This order shall be effective when issued.
