ORDER SHORTENING TIME FOR RESPONSES AND DIRECTING FILING

On September 15, 2021, the Commission issued its *Order Approving Stipulation and Agreement, Resolving Annual Fuel Adjustment Clause True-Up, And Directing Filing of Substitute Tariff* (September 15th Order). That order directed Union Electric Company d/b/a Ameren Missouri to file a substitute tariff sheet identical to the one attached to the stipulation and agreement approved by the Commission in the September 15th Order. Ameren Missouri filed a substitute tariff sheet on September 15, 2021. The tariff sheet bears an October 1, 2021 effective date.

The Commission will shorten the time for responses to the substitute tariff sheet. Additionally, the Commission will direct the Staff of the Commission (Staff) to review the substitute tariff sheet and inform the Commission as to whether the substitute tariff sheet complies with the Commission's September 15th Order.

THE COMMISSION ORDERS THAT:

1. Any responses to the substitute tariff sheet shall be filed no later than September 24, 2021.
2. No later than September 24, 2021, Staff shall review the substitute tariff sheet and inform the Commission as to whether it complies with the Commission's September 15th Order.
3. This order shall be effective when issued.
