On November 13, 2024, Vicinity Energy Kansas City, Inc. (VEKC) submitted an application requesting approval to its current Deed of Trust financing. VEKC requested expedited treatment such that the Commission issue an order no later than December 11, 2024. VEKC also requested waiver of the 60-day notice requirement under Commission Rule 20 CSR 4240-4.017.

The Commission will direct the Staff of the Commission (Staff) to file a Recommendation regarding VEKC's application or a status report addressing when it expects to file the Recommendation.

THE COMMISSION ORDERS THAT:

1. No later than December 2, 2024, Staff shall file a Recommendation or a status report regarding when it expects to file its Recommendation.
2. This order shall be effective when issued.
