On November 4, 2024,<sup>1</sup> The Empire District Electric Company d/b/a Liberty (Liberty or “the Company”) filed a Motion for Protective Order (Motion). The Commission granted the Motion on November 5.

On November 14, the Office of the Public Counsel (Public Counsel) filed a request that the protective order include certain disclosure requirements.

The Commission will direct that Liberty respond, and will also set a time for any other party to respond.

**THE COMMISSION ORDERS THAT:**

1. Liberty shall file its response to Public Counsel’s request to add certain disclosure requirements no later than November 19, 2024.
2. Any other responses to Public Counsel’s request to add certain disclosure requirements shall be filed no later than November 19, 2024.
3. This order shall be effective when issued.
