**ORDER SETTING HEARINGS AND COMMENT PERIOD**

On September 25, 2024, the Commission issued findings of necessity and directed the Secretary of the Commission to file three proposed rules and seven proposed rescissions in the above-captioned files. The proposed rules and proposed rescissions were filed with the Secretary of State the same day. The

proposed rescissions and proposed rules were published in the *Missouri Register* on November 1, 2024.<sup>1</sup>

Due to an inadvertent error, the hearings regarding these proposed rules and proposed rescissions were published as being scheduled on two separate dates. The intention of the Commission was to schedule all hearings for the same date -- December 10, 2024. Therefore, the Commission issues this order to notify all interested persons that the Commission will hold rulemaking hearings as published in the *Missouri Register*. However, because these rules and rescissions are so interrelated, the Commission will hold the rulemaking hearing currently scheduled for December 6, 2024, open and will receive comments on all the proposed rules and proposed rescissions at the December 10, 2024 rulemaking hearing.

Anyone may file comments in support of or in opposition to these proposed rules and proposed rescissions with the Missouri Public Service Commission, Nancy Dippell, Secretary of the Commission, PO Box 360, Jefferson City, MO 65102. Comments may also be submitted via a filing using the Commission's electronic filing and information system (EFIS) at <https://efis.psc.mo.gov/case>. To be considered, comments must be received as set out in the ordered paragraphs below.

1. The Commission will hold rulemaking comment hearings on December 6 and **December 10, 2024**. The hearings will begin at **10:00 a.m.** on each day. The hearings will be held in **Room 139 of the James C. Kirkpatrick**

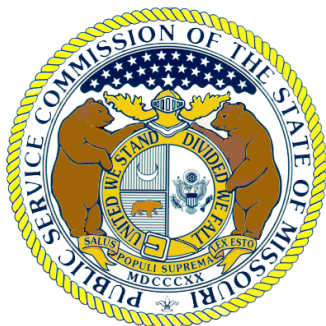
