ORDER APPROVING TARIFF IN COMPLIANCE WITH COMMISSION REPORT AND ORDER

Issue Date: December 20, 2019 Effective Date: January 1, 2020

On December 11, 2019, the Commission issued a Report and Order modifying and approving Evergy Missouri Metro and Evergy Missouri West's (Evergy Missouri) demand-side programs and Demand-Side Investment Mechanism (collectively, "MEEIA Cycle 3") pursuant to the Missouri Energy Efficiency Investment Act¹ (MEEIA). The Commission ordered Evergy Missouri to file new tariffs in compliance with that Report and Order. On December 16, 2019, Evergy Missouri filed compliance tariffs. On December 18, 2019, Evergy Missouri filed a motion for expedited treatment, requesting that the tariff sheets become effective on January 1, 2020. The tariff sheets show an effective date of January 15, 2020, but Evergy Missouri's motion for expedited treatment asks the Commission to approve the compliance tariffs to take effect in less than thirty days to correspond with the ending of MEEIA Cycle 2 on December 31, 2019, and prevent any gap in Evergy Missouri's MEEIA programs.

The Commission ordered its Staff to file a recommendation on the compliance tariffs by December 20, 2019, at 10:00 a.m. Other parties were given until

December 20, 2019, at 10:00 a.m. to file any comments or recommendations regarding the compliance tariffs. Staff timely filed its recommendation advising that the tariffs comply with the Commission's Report and Order. Staff advises approval of the tariffs. No other party has filed an objection or response regarding the tariffs.

The Commission finds that Evergy Missouri has demonstrated good cause to grant the motion for expedited treatment and make the tariffs effective in less than thirty days, because doing so avoids a gap in its MEEIA programs. The Commission concludes that the submitted tariffs should be approved to be effective January 1, 2020.

THE COMMISSION ORDERS THAT:

- Evergy Missouri Metro and Evergy Missouri West's motion for expedited treatment is granted.
- 2. The tariff sheets submitted by Evergy Missouri Metro and Evergy Missouri West are approved. Tariff Nos. YE-2020-0100, YE-2020-0101, JE-2020-0102, and YE-2020-0103, as substituted, are effective on and after January 1, 2020.
 - 3. This order shall be effective on January 1, 2020.
