The revised tariff sheets bearing an effective date of April 7, 2017, have been reviewed by Staff and are recommended for approval as explained in Staff's Memorandum attached as Appendix A for File No. EO-2015-0240, Tariff Tracking No. YE-2017-0172.

2. GMO filed its tariff sheets on March 8th to also remove incorrect references to Commission rule 4 CSR 240-20.094(4). On March 9th GMO filed
