ANNUAL UPDATE POST-WORKSHOP SUMMARY REPORT

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company"), and for its Annual Update Post-Workshop Summary Report, states as follows:

 On October 1, 2024, Ameren Missouri filed its 2024 Integrated Resource Plan (IRP) Annual Update Report pursuant to 20 CSR 4240-22.080(3).

2. On November 6, 2024, Ameren Missouri hosted its annual update workshop with its stakeholder group. Attendees included representatives from the Missouri Public Service Commission Staff, the Office of Public Counsel, Renew Missouri, Council for the New Energy Economics, Clean Grid Alliance, Sierra Club, Consumers Council of Missouri, Dutchtown South Community Corporation, Grain Belt Express LLC, Homes for All St. Louis, Midwest Energy Consumers Group, Missouri Electric Commission, Missouri Industrial Energy Consumers, and the Natural Resources Defense Council.

3. Ameren Missouri hereby files this Annual Update Post-Workshop Summary Report in compliance with 20 CSR 4240-22.080(3)(C), which requires that the utility file a report listing and describing any action items resulting from the workshop to be undertaken by the utility prior to the next triennial compliance filing or annual update filing.

4. There is only one action item to be undertaken by Ameren Missouri as a result of the workshop. During the workshop, stakeholders had asked about Ameren Missouri's recent renewable solutions program auction for renewable energy subscriptions for the Cass County solar project. Specifically, stakeholders inquired about the quantity of megawatts for which

customers wished to purchase a subscription but were unable to do so because Ameren Missouri sold out of capacity. Ameren Missouri did not have this information handy during the workshop and undertook to gather this information. Ameren Missouri hereby provides an answer: customers tried to purchase subscriptions for 232 megawatts of clean energy, but Ameren Missouri's Cass County project had only 150 megawatts of capacity available. This left 82 megawatts unsold to five auction bidders that missed out.

5. Additionally, Ameren Missouri makes a correction made to an answer given during the workshop. Ameren Missouri was asked about its basis adjustment to Henry Hub natural gas prices. This basis adjustment is based on future expectations and is not based on historical prices as stated during the workshop.

6. Ameren Missouri will not be making any changes to its 2024 Annual Update Report.

WHEREFORE, Ameren Missouri requests the Missouri Public Service Commission accept this summary report.
