
Matrix Telecom, LLC d/b/a Matrix Business Technologies, d/b/a VarTec Telecom d/b/a Excel Telecommunications, d/b/a Impact Telecom d/b/a Startec, d/b/a Americatel (Matrix) sent the Commission a letter dated November 26, 2019, advising that it is adding a new d/b/a Lingo under which it will market services in Missouri effective January 1, 2020. The Commission directed its Staff to file a recommendation regarding that notice by December 19.

On December 18, Matrix filed a letter withdrawing its previous notice of name change, indicating it will refile the notice at a later date. Staff filed its recommendation on December 19, advising the Commission to close this file in light of Matrix's withdrawal of its notice. The Commission will do so.
