## ORDER SETTING TIME FOR RESPONSES

The Staff of the Commission filed its recommendation regarding its examination and analysis of Union Electric Company d/b/a Ameren Missouri's tariff filing intended to adjust its Energy Efficiency Investment Charge (EEIC). In its recommendation, Staff proposed different adjustments to become effective on or after February 1, 2020. These adjustments concern an issue that has not previously been addressed in these types of cases – a rebasing adjustment. Staff stated that it and Ameren Missouri are continuing discussions on these matters. The Commission will direct responses to Staff's recommendation as set out below.

### THE COMMISSION ORDERS THAT:

1. Union Electric Company d/b/a Ameren Missouri shall file a response to the Staff recommendation no later than January 6, 2020.
2. Any other party wishing to file a response to Staff's recommendation shall do so no later than January 6, 2020.
3. This order shall be effective when issued.


