ORDER DIRECTING FILING

On August 20, 2019,¹ the Commission's Staff filed a First Amended Complaint against Central Rivers Wastewater Utility, Inc. (Central). On August 21, the Commission issued an *Order Retitling Pleading and Second Notice of Contested Case and Order Directing Filing*. On December 20, the Commission ordered the Staff to file a status report. On December 23, the Staff filed a status report stating that since the filing of Staff's Complaint, Elm Hills Utility Operating Company, Inc. had filed a request in File SM-2020-0146 (Elm Hills file) to acquire all or substantially all Central's assets, including its certificate of convenience and necessity. Staff recommended the Commission stay this matter until the Commission has issued an order in the Elm Hills File.

On December 2, the Commission issued its Order Directing Notice and Filing in the Elm Hills file, directing Staff to file either a status report or a recommendation no

later than January 17, 2020. The Commission will order Staff to file further status reports in this file.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a status report in this file no later than January 17, 2020. Thereafter, commencing with March 1, 2020, the Staff shall file status reports in this file no less frequently than every two months, same to be due no later than the first calendar day of the month.

2. This order will be effective when issued.
