ORDER CANCELING EVIDENTIARY HEARING

At the parties' request, the Commission delayed the start of the evidentiary hearing in this rate case until Wednesday, November 20, 2024. On November 19, 2024, Liberty Utilities (Missouri Water) LLC d/b/a Liberty filed a motion on behalf of all the parties to suspend the procedural schedule and cancel the evidentiary hearing. The motion states that the parties have agreed on terms for a global settlement and ask to have two weeks to submit a stipulation and agreement resolving all the issues in this rate case.

The Commission will cancel the evidentiary hearing set to begin on November 20, 2024, and set a deadline for submission of a global settlement.

THE COMMISSION ORDERS THAT:

1. The evidentiary hearing scheduled for November 20-22, 2024, is canceled.
2. The parties shall file a global settlement no later than December 4, 2024.
3. This order is effective when issued.
