On August 28, 2015, KCP&L Greater Missouri Operations Company applied to the Commission for approval of Demand-Side Programs and for authority to establish a Demand-Side Investment Mechanism as contemplated by the Missouri Energy Efficiency Investment Act and the Commission's implementing regulations.

The deadline for persons requesting to intervene in this matter was September 14, 2015. The Commission received timely applications to intervene from the following entities: the Missouri Department of Economic Development-Division of Energy; Natural Resources Defense Council; Earth Island Institute d/b/a Renew Missouri; the National Housing Trust; Missouri Industrial Energy Consumers; Union Electric Company d/b/a Ameren Missouri; United for Missouri, Inc.; Brightergy, LLC; West Side Housing Organization. Sierra Club filed an application to intervene, but withdrew its application on September 15, 2015. Ten days have elapsed, and no parties have objected to the applications. The Commission concludes that the applications satisfy all requirements of Commission Rule 4 CSR 240-2.075(3) for intervention and will be granted.
