PROTECTIVE ORDER

On November 20, 2024, Missouri-American Water Company (MAWC) filed a *Motion for Protective Order and Expedited Treatment*, stating that, due to the nature of certain material regarding financial matters that are competitively sensitive, security sensitive information, and certain cyber security materials, the "confidential" designation under Commission Rule 20 CSR 4240-2.135 may not provide adequate protection.

MAWC requests a protective order pursuant to Commission Rule 20 CSR 4240-2.135(4) allowing it, or other parties, to designate certain information as "Highly Confidential" prior to disclosure. MAWC states that no party objects to the motion.

Upon review of the motion, the Commission finds the request for a protective order reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. The motion for a protective order is granted.

2. Materials and information divulged by MAWC or other parties shall be considered to be "Highly Confidential" if so designated at the time of disclosure.

3. With regard to entities and individuals other than the Staff of the Commission and the Office of the Public Counsel:

- a. Disclosure of materials or information designated "Highly Confidential" shall be made only to attorneys and/or to such outside consultants who have executed a Commission Nondisclosure Agreement. No Highly Confidential information shall be provided directly or indirectly to any non-attorney individual or employee.
- b. Persons afforded access to materials or information designated "Highly Confidential" shall neither use nor disclose such materials or information for purposes of business or competition or any other purpose other than in regard to the above-referenced case and shall keep the materials and information secure and confidential and in accordance with the purposes and intent of the protective order.
- c. All material and information designated as "Highly Confidential" in the possession of any entity or person, as well as any notes pertaining to such information, shall be returned to MAWC (or the disclosing party) or destroyed upon the conclusion of the above-referenced case.

4. If a party disagrees with the "Highly Confidential" designation of any information, the party shall follow the informal discovery dispute resolution procedures set forth in Commission Rule 20 CSR 4240-2.090(8). If the party exhausts these dispute resolution procedures, the party may file a motion challenging the designation.

5. Except for attorneys of record for all parties, and employees of state agencies covered by statutory confidentiality requirements, all persons authorized to access "confidential" information in this case shall complete the nondisclosure agreement attached to this order as Exhibit A.

6. Except for attorneys of record for all parties, and employees of state agencies covered by statutory confidentiality requirements, all persons authorized to access "highly confidential" information in this case shall complete the nondisclosure agreement attached to this order as Exhibit B.

7. This order shall be effective when issued.
