ORDER DIRECTING RESPONSES TO COMPLIANCE TARIFF

On April 18, 2024,¹ TBJ Sewer Systems, Inc. (TBJ) filed a notice requesting an increase in its annual overall operating revenues in a staff assisted sewer rate case. On November 19, the parties filed a unanimous disposition agreement resolving all issues. On November 20, TBJ filed tariff sheets purporting to comply with the pending disposition agreement, bearing an effective date of January 3, 2025, and assigned Tracking No. JS-2025-0074.

The Commission will direct the Staff of the Commission (Staff) to file a recommendation as to whether the tariff complies with the disposition agreement and will also set a deadline for other parties to file responses.

THE COMMISSION ORDERS THAT:

1. On or before December 4, 2024, Staff shall file a recommendation as to whether the tariff sheets filed comply with the disposition agreement.
2. Any other party wishing to file a response regarding the tariff sheets filed shall do so no later than December 4, 2024.
3. This order shall be effective when issued.
