On October 30, 2024, the Commission issued a *Report and Order Approving Addendum to Territorial Agreement* in this matter. Among other things, that order directed Union Electric Company d/b/a Ameren Missouri to submit revised tariff sheets to reflect the change in its certificated electric service area in Cooper County resulting from the order.

On November 21, 2024, Ameren Missouri filed a tariff sheet, bearing an effective date of January 2, 2025, and assigned Tracking No. JE-2025-0076, purporting to comply with the terms of the Commission's October 30th order.

The Commission will ask its Staff to file a recommendation advising the Commission as to whether the submitted revised tariff sheet complies with the Commission's October 30th order.

- 1. Staff shall file a recommendation regarding Ameren Missouri's revised tariff sheet (Tracking No. JE-2025-0076) no later than December 6, 2024.
 - 2. This order shall be effective when issued.
