## ORDER PROVIDING NOTICE, ESTABLISHING INTERVENTION DEADLINE, AND DIRECTING RESPONSE

On November 19, 2024, Spire Missouri Inc.'s d/b/a Spire filed an Integrated Resource Plan (IRP) as required by the Commission approved stipulation and agreement in File No. GR-2021-0127. Under that stipulation and agreement Spire is to file an IRP and update that IRP every three years. Spire's IRP is to include both a Non-Pipes Alternative Pilot, which is a plan to pilot at least one Non-Pipes Alternative to identify cost-effective and environmentally beneficial pathways to meet customer demand. The IRP is also to include a Long-Term Climate Plan with a 20-year demand forecast and a corresponding 20-year supply forecast, among other requirements.

The Commission will provide notice to potentially interested parties, and will establish an intervention deadline. The Commission will also direct its Staff to file a pleading stating when it can file a recommendation about Spire's IRP.

### THE COMMISSION ORDERS THAT:

1. Any person or entity wishing to intervene in this matter shall file an application to do so no later than December 19, 2024.
2. No later than December 11, 2024, Staff shall file a pleading stating when it can file a recommendation about Spire's IRP.

3. This order is effective when issued.
