On June 6, 2024, Spire Missouri Inc. (Spire) filed an application seeking permission and approval and a certificate of convenience and necessity ("CCN") to construct, install, own, operate, maintain, and otherwise control and manage natural gas distribution systems throughout the state of Missouri and for approval to acquire natural gas assets of Southern Star Central Gas Pipeline, Inc. On November 21, 2024, the Commission issued an Order granting the application.

On November 21, 2024, Spire filed a *Motion for Expedited Treatment* along with a tariff sheet to implement the order. That tariff bears an effective date of December 21, 2024. The *Motion for Expedited Treatment* asks the Commission to approve the tariff to become effective no later than December 6, 2024.

The Commission will order its Staff to file an expedited Recommendation, and will allow time for responses.

THE COMMISSION ORDERS THAT:

- 1. The Staff of the Commission shall file a Recommendation or alternative pleading, no later than December 2, 2024.
- 2. Any other responses to the tariff sheet or the motion for expedited treatment shall be filed no later than December 2, 2024.
