## ORDER DISMISSING CASE

On February 1, 2016, Gerald Fuemmeler filed an application with the Missouri Public Service Commission requesting that his electric supplier be changed from Kansas City Power & Light Company ("KCP&L") to The City of Salisbury ("Salisbury"). The Staff of the Commission filed a recommendation on March 16, 2016. Staff recommends the Commission deny the application because no electric utility provides service to the property in question, and because Salisbury cannot legally serve the property because it is outside Salisbury's city limits. KCP&L responded on March 30, 2016, stating it was working with the parties to resolve their issues. The file has been dormant ever since March 30, 2016.


Commission Rule 4 CSR 240-2.116(2) allows the Commission to dismiss cases for lack of prosecution if no action has occurred for 90 days and no party has asked for a continuance. On March 20, 2018 the Commission allowed parties until March 30, 2018 to state why the Commission should not dismiss this case. The Commission received no responses.

The Commission will dismiss this case.

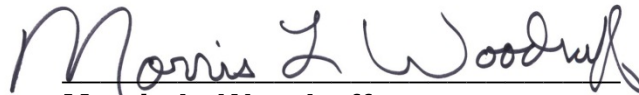
