On November 1, 2024, Union Electric Company d/b/a Ameren Missouri filed a revised tariff sheet designed to extend the Voluntary Green/Pure Power pilot program through June 30, 2026. Ameren Missouri stated that the revision was consistent with the stipulation and agreement approved in its rate case. The tariff sheet bears an effective date of December 1, 2024.

The Commission will direct its Staff to file a recommendation regarding the tariff revision. The Commission will allow any other party to file a response to the tariff.
