## ORDER CONTINUING PROCEDURAL CONFERENCE

On November 27, 2019, the Missouri Industrial Energy Consumers, the Office of Public Counsel, and Midwest Energy Consumers Group (collectively "Joint Movants"), filed a motion requesting that the December 30, 2019, procedural conference be continued to another date. In support of their motion Joint Movants suggest that there is insufficient time to consider and analyze Staff's recommendation, which was filed on December 27, 2019. Joint Movants state that neither Ameren Missouri nor the Commission's Staff object to the motion.

The Commission will continue the procedural conference to allow the parties additional time to review Staff's recommendation. The parties shall appear in person or by telephone at the conference unless excused by the regulatory law judge.

### THE COMMISSION ORDERS THAT:

1. The procedural conference set for December 30, 2019, at 9:00 a.m. is cancelled.
2. A procedural conference will be held on January 17, 2020, beginning at 10:00 a.m. in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson

City, Missouri. This meeting will be held in a building that meets accessibility standards required by the Americans with Disabilities Act.
