ORDER CANCELING REGISTRATION

Issue Date: December 30, 2019

Effective Date: January 29, 2020

On December 13, 2019, Power On Technologies, Inc. (Power On) notified the Commission that the company no longer wished to be registered as an IVoIP provider in Missouri. The Commission granted Power On registration to provide IVoIP services in the State of Missouri in File Number DA-2018-0361.

On December 18, 2019, the Commission issued an *Order Establishing Time to Respond* directing Staff to file a recommendation. On December 19, 2019, Staff filed a recommendation to cancel Power On's registration.

No objections or requests for a hearing were filed. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹

Based on Power On's request and Staff's recommendation, the Commission finds that the IVoIP registration granted to Power On shall be canceled.

1. The registration to provide Interconnected Voice over Internet Protocol services granted to Power On Technologies, Inc., in File Number DA-2018-0361, is canceled.
2. This order shall become effective on January 29, 2020.
3. This case may be closed on January 30, 2020.
