STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), through the undersigned counsel, and for its *Staff Recommendation*, respectfully states as follows:

- 1. On September 27, 2024, Union Electric Company, d/b/a Ameren Missouri ("Ameren Missouri") filed a tariff and supporting testimony to implement a rate adjustment under its Renewable Energy Standard Rate Adjustment Mechanism ("RESRAM") for the 6th accumulation period ending July 31, 2024, pursuant to Commission Rule 20 CSR 4240-20.100. The submitted tariff sheet bore an effective date of February 1, 2025. On the same day, the Commission issued its *Order Directing Notice*, *Setting Intervention Deadline, and Directing Staff Recommendation*, ordering Staff to "file a recommendation regarding its examination and analysis of Ameren Missouri's RESRAM no later than November 26, 2024."
- 2. As detailed in Staff's Memorandum, attached and incorporated herein as Appendix A, Staff reviewed Ameren Missouri's data and calculation related to its proposed tariff sheet and recommends that the Commission issue an order approving the following tariff sheet or allowing the tariff sheet to go into effect by operation of law on February 1, 2025:

BACKGROUND

On September 27, 2024, Union Electric Company, d/b/a Ameren Missouri ("Ameren Missouri") filed a tariff and supporting testimony to implement a rate adjustment under its Renewable Energy Standard Rate Adjustment Mechanism ("RESRAM") for the 6th accumulation period ending July 31, 2024, pursuant to Commission Rule 20 CSR 4240-20.100. The submitted tariff sheet bore an effective date of February 1, 2025 and filed under Tariff Tracking No. JE-2025-0043.

The total RESRAM expense balance for the accumulation period ending July 31, 2024 was \$61,977,596. Total Renewable Energy Standard Costs Recovered for the same accumulation period were \$25,761,307. Subtracting this recovery and adding interest of \$2,761,617 produces a RES under recovery totaling \$38,977,906. Ameren Missouri calculated the annual RESRAM Revenue Requirement going forward to be \$54,771,701¹ and Ameren Missouri calculated a current true-up amount of \$1,331,659. Adding these amounts together results in total RESRAM Recoveries of \$95,081,266 to be collected from February 1, 2025 through January 31, 2026.

Using Ameren Missouri's projected energy level of 30,408,985,779 kWh and the total RESRAM recoveries mentioned above, the RESRAM rate will be \$0.00313 per kWh. Customers using 1,000 kWh per month will see a \$3.13 billing charge which is a \$1.09 (or 53.4%) increase per month when compared to the previous period RESRAM rate of \$0.00204 per kWh. Application of this rate will not exceed the annual rate cap pursuant to Section 393.1655 RSMo.

¹ RESRAM Revenue Requirement is calculated per tariff formula which deducts a RESRAM Base Amount established in case number ER-2022-0337 from annualized expenses.
