On December 18, 2019, Spire Missouri Inc. d/b/a Spire filed a revised tariff sheet to update the key benchmark that is used as the standard by which savings under the Spire East Gas Supply Incentive Plan (GSIP) are measured. The tariff sheet bears an effective date of January 17, 2020. The Staff of the Commission asks the Commission to suspend the tariff sheet 120 days to allow Staff to investigate.

The Commission will order Spire to respond and set a deadline for any other comments.

THE COMMISSION ORDERS THAT:

1. Spire Missouri Inc. d/b/a Spire shall respond to the Staff of the Commission's request to suspend the tariff sheet no later than January 6, 2020.
2. Any party wanting to comment on Spire Missouri Inc. d/b/a Spire's response or Spire's tariff sheet shall do so no later than January 9, 2020.
3. This order is effective when issued.


