On October 2, 2024, the Commission issued a *Finding of Necessity and Order Directing Proposed Rule 20 CSR 4240-10.185 be Filed for Publication*. The proposed rule was filed with the Secretary of State the same day. The proposed rule was published in the *Missouri Register* on November 15, 2024.

Anyone may file comments in support of or in opposition to the proposed rule with the Missouri Public Service Commission, Nancy Dippell, Secretary of the Commission, PO Box 360, Jefferson City, MO 65102. To be considered, comments must be received at the Commission's offices on or before December 15, 2024, and should include a reference to Commission File No. OX-2025-0118. Comments may also be submitted via a filing using the Commission's electronic filing and information system (EFIS).

A public hearing regarding the proposed rule is scheduled for **December 18, 2024, at 1 p.m., in Room 139 of the James C. Kirkpatrick Building**, 600 W. Main St., Jefferson City, MO. Interested persons may appear at this hearing to submit additional comments and/or testimony in support of or in

opposition to this proposed rule, and may be asked to respond to Commission questions.
