RE: Notice of Change in Corporate Form and Name Change for Comcast of Missouri, Inc.

Dear Judge Dippell:

Pursuant to 20 CSR 4240-28.011 and 20 CSR 4240-31.015, Comcast of Missouri, Inc. ("Comcast"), by its attorneys, respectfully notifies the Missouri Public Service Commission ("Commission") of its change in name to Comcast of Missouri, LLC. Comcast currently holds authority to provide video service in various political subdivisions across Missouri pursuant to Docket No. KA-2009-0117 and Docket No. KA-2009-0325. Comcast is currently seeking a franchise to provide video service in additional political subdivisions under Docket No. KA-2025-0160.

Effective August 31, 2012, Comcast converted to a Missouri limited liability company, and now operates under the name Comcast of Missouri, LLC. Documentation from the State of Missouri reflecting the conversion and name change is attached.

On September 4, 2012, pursuant to the procedures of the Missouri Secretary of State, Comcast filed (1) Application for Registration of a Foreign Limited Liability Company; and on January 7, 2013, Comcast filed (2) Application for Certificate of Withdrawal of Foreign Corporation to withdraw Comcast of Missouri, Inc.'s registration as a foreign corporation in the State of Missouri; and filed Comcast's (3) Amendment of a Foreign Limited Liability Company, changing the name of the limited liability company to be used in Missouri from Comcast of MO, LLC to Comcast of Missouri, LLC. Accompanying this letter are the filed Application for Registration of a Foreign Limited Liability Company with approval documentation from the Missouri Secretary of State, Application for Certificate of Withdrawal of Foreign Corporation, Amendment of a Foreign Limited Liability Company, and Comcast of Missouri, LLC's State of Missouri Certificate of Good Standing.
