ORDER GRANTING LEAVE TO APPEAR PRO HAC VICE

On November 25, 2024, Cole A. Bailey filed a motion for leave to appear *pro hac vice* as an attorney for Evergy Metro, Inc. d/b/a Evergy Missouri Metro (EMM).
