## NOTICE OF APPLICATION AND ORDER DIRECTING FILING

On August 16, 2016, Union Electric Company d/b/a Ameren Missouri (the Company), a Missouri corporation, and Platte-Clay Electric Cooperative, Inc. (Cooperative), (collectively, Joint Applicants) filed a joint application asking the Commission to approve a territorial agreement pursuant to Sections 393.106 and 394.312, RSMo.

The Commission will provide notice of the filing of this territorial agreement to the public. In addition, the Commission will establish a deadline for the filing of applications to intervene and will order its Staff to file a recommendation regarding the joint application. If no party files a motion for an evidentiary hearing, the Commission may deem the right to an evidentiary hearing waived. The controlling statute requires the Commission to rule on the application no later than 120 days from the date the application was filed.

### THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall send a copy of this order to the County Commissions of Ray, Clinton, Caldwell, and Clay Counties, Missouri.

2. The Commission's Public Information Office shall make notice of this order available to the members of the General Assembly representing Ray, Clinton, Caldwell, and Clay Counties, Missouri and to the newspapers serving those counties.

3. Applications to intervene shall be filed no later than September 1, 2016.

4. The Commission's Staff shall file a recommendation regarding the joint application no later than September 15, 2016.

5. This order shall be effective when issued.
