### ORDER APPROVING COMPLIANCE TARIFF

Issue Date: May 2, 2017 Effective Date: May 7, 2017

The Commission issued a *Report and Order Approving Territorial Agreement* on November 17, 2016, approving a territorial agreement between Union Electric Company d/b/a Ameren Missouri and Platte-Clay Electric Cooperative, Inc. Ameren Missouri filed tariff sheets (Tariff Nos. YE-2017-0193) setting out the territorial boundaries as approved in compliance with that order on April 7, 2017. The tariff sheets have a May 7, 2017 effective date.

The Commission issued an order setting an April 20, 2017 deadline for the filing of responses and for a recommendation from the Staff of the Missouri Public Service Commission (Staff). Staff responded recommending approval of the tariff sheets and indicating that the tariff sheets were in compliance with the Commission's order. Staff recommended that the tariff sheets be allowed to become effective no later than May 7, 2017. No other responses were received.

Based on its review of the Staff's recommendation, the Commission finds that Ameren's tariff sheets comply with the Commission's November 17, 2016 order and will

approve it. Staff recommends the tariff sheets become effective on May 7, 2017, there were no objections to the tariff sheets which were filed with a 30-day effective date, and the tariff sheets are in compliance with a previous Commission order. Therefore, the Commission will issue this order to become effective in less than 30 days.

#### THE COMMISSION ORDERS THAT:

1. The following tariff sheets, bearing Tariff No. YE-2017-0193, filed on April 7, 2017 by Union Electric Company d/b/a Ameren Missouri, is approved to become effective on May 7, 2017:
