ORDER DENYING APPLICATION FOR REHEARING

On February 28, 2018, the Commission issued an amended report and order regarding the sixth prudence review of The Empire District Electric Company's Fuel Adjustment Clause.¹ That amended report and order became effective on March 10. The Office of the Public Counsel filed a timely application for rehearing regarding the amended report and order on March 9.

Section 386.500.1, RSMo (2016), indicates the Commission shall grant an application for rehearing if "in its judgment sufficient reason therefor be made to appear." In the judgment of the Commission, Public Counsel has not shown sufficient reason to rehear the amended report and order. The Commission will deny the application for rehearing.

¹ The Commission issued its original report and order on January 3, 2018. Public Counsel previously filed an application for rehearing regarding that report and order on February 1, 2018.

1. Public Counsel's Second Application for Rehearing is denied.
