**ORDER DIRECTING A STAFF TARIFF RECOMMENDATION AND  
SETTING TIME FOR RESPONSES**

On November 25, 2024, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy West) filed a proposed tariff revision, Tracking No. JE-2025-0079, which bears an effective date of December 25, 2024. The proposed true-up tariff sheets are designed to satisfy the requirement that Evergy West adjust for any over collection or under collection at least annually. The Commission will direct its Staff (Staff) to file a recommendation about the proposed tariff sheets, and will set a time for filing any other comments.

**THE COMMISSION ORDERS THAT:**

1. Staff shall file a recommendation or status report about Evergy West's proposed tariff sheets no later than December 6, 2024.
2. Any other comments about Evergy West's tariff sheet shall be filed no later than December 6, 2024.

3. This order is effective when issued.
