ORDER DIRECTING A STAFF RESPONSE

On September 27, 2024, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively "Evergy"), Renew Missouri, and the Office of the Public Counsel submitted a Stipulation and Agreement (Agreement) as a resolution of Evergy's Missouri Energy Efficiency Investment Act (MEEIA) Cycle 4 application. Staff was not a signatory to the Agreement, but did not object to it.

Due to the lack of detail in the Agreement, the Commission directed Evergy to submit substitute tariff sheets reflective of the Agreement. Staff filed a recommendation about those substitute tariff sheets stating that while they comply with the agreement they lack the level of detail and specificity Staff believes is necessary for a MEEIA portfolio.

The Commission directed Evergy to respond to Staff's tariff recommendation with sufficient detail to justify the Commission considering the Agreement and associated tariff sheets and a reasonable resolution of Evergy's proposed MEEIA Cycle 4.

Evergy filed substitute tariff sheets and workpapers on November 25, 2024. The Commission will direct its Staff (Staff) to file a recommendation about the tariff sheet, and will set a time for filing any other comments.

THE COMMISSION ORDERS THAT:

- 1. Staff shall file a recommendation about Evergy's tariff sheets no later than December 6, 2024.
- 2. Any other comments about Evergy's tariff sheets shall be filed no later than December 6, 2024.
 - 3. This order is effective when issued.
