On October 26, 2016, Union Electric Company d/b/a Ameren Missouri ("Ameren") asked the Commission to allow Ameren to sell a transformer to Mercy Health East Communities, Southern Region ("Mercy Health"). The Commission ordered its Staff to file a Recommendation no later than December 13, 2016.

On December 8, Staff stated that, due to the press of business, it needs until January 27, 2017 to file its Recommendation. As such, Staff moves the Commission for an extension of time to file its Recommendation.

The Commission finds the motion reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. The Motion for Extension of Time is granted.
2. The Staff of the Commission shall file a Recommendation or alternative pleading no later than January 27, 2017.
