On February 6, 2017, Roger Pritchett filed an application with the Missouri Public Service Commission requesting that his electric supplier be changed from The Empire District Electric Company to Ozark Electric Cooperative, Inc. On June 29, 2017, Mr. Pritchett filed an email with the Commission voluntarily dismissing his application.

Commission Rule 4 CSR 240-2.116(1) states that an applicant may dismiss an application without an order of the Commission before prepared testimony or oral evidence has been offered. The parties have not offered prepared testimony or oral evidence. The Commission, therefore, will take notice of Mr. Pritchett's dismissal. This case shall be closed.
