ORDER GRANTING APPLICATION TO INTERVENE

On April 13, 2017, KCP&L Greater Missouri Operations Company (GMO) filed its 2016 Renewable Energy Standard Compliance Report, as required by Commission Rule 4 CSR 240-20.100(8). The Missouri Department of Economic Development, Division of Energy (DE) applied to intervene on April 19.

This is not a contested case, and any interested person or entity may file comments regarding GMO’s report without the necessity of applying to be a party to this proceeding. However, under the Commission’s confidential information rule, 4 CSR 240-2.135, confidential information may only be disclosed to a party. Therefore, DE must be made a party if it is to see the confidential portions of GMO’s report.

The Commission finds that allowing DE to intervene will serve the public interest. Therefore, in accordance with Commission Rule 4 CSR 240-2.075(3), the Commission will grant DE’s application to intervene.

THE COMMISSION ORDERS THAT:

1. Missouri Division of Energy’s Application to Intervene is granted.

2. This order shall be effective when issued.
