Kansas City Power & Light Company (KCP&L) filed its 2017-2019 Renewable Energy Standard Compliance Plan on April 13, 2017. Commission Rule 4 CSR 240-20.100(8) requires Staff to file a report about the compliance plan, and offers other interested persons or entities an opportunity to file comments. Staff filed its report on May 25.

Commission Rule 4 CSR 240-20.100(8)(F) allows the Commission to direct KCP&L to provide additional information or to address any concerns or deficiencies identified by Staff or any other commenter. Before deciding whether any additional information is required or whether any concerns or deficiencies need to be addressed, the Commission will establish a time for the filing of responses to Staff's report.

**THE COMMISSION ORDERS THAT:**

1. Any person or entity wishing to respond to Staff's Report on Kansas City Power & Light Company's 2017-2019 Renewable Energy Standard Compliance Plan shall do so no later than June 15, 2017.

2. This order shall be effective when issued.
