On September 25, 2017, Union Electric Company d/b/a Ameren Missouri filed its 2017 Integrated Resource Plan, as required by the Commission's Electric Utility Resource Planning Rule, 4 CSR 240-22. The purpose of an Integrated Resource Plan is to ensure investor-owned utilities consider all options, including demand side efficiency and energy management measures, to provide safe, reliable, and efficient electric service to the public at reasonable rates.

The Commission will give notice of Ameren Missouri's filing to potentially interested parties and will set a date for the filing of requests to intervene.

**THE COMMISSION ORDERS THAT:**

1. The Commission's Data Center shall mail a copy of this order to each party to Ameren Missouri's most recent Special Contemporary Resource Planning Issues case, File No. EO-2017-0073.

2. The Commission's Public Information Office shall make notice of this order available to the media and members of the General Assembly serving Union Electric Company d/b/a Ameren Missouri's service area.

3. Any entity wishing to intervene in this matter shall file an application no later than October 16, 2017. Applications may be filed with the Secretary of the Missouri Public Service Commission or through the Commission's Electronic Filing Information System (EFIS).

4. This order shall be effective when issued.
