ORDER GRANTING EXTENSION

On November 13, 2024,¹ Vicinity Energy Kansas City, Inc. (VEKC) submitted an application requesting approval to its current Deed of Trust financing.

The Staff of Commission (Staff) was directed to file a recommendation no later than December 2. On December 2, Staff filed a request for an extension to January 2, 2025, as it received data request responses from VEKC on December 1. Staff stated it needs time to review those responses and conduct further discovery, if needed.

The Commission finds Staff's request for an extension reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's request for an extension of time is granted. Staff shall file a recommendation regarding VEKC's application no later than January 2, 2025.
2. This order is effective when issued.

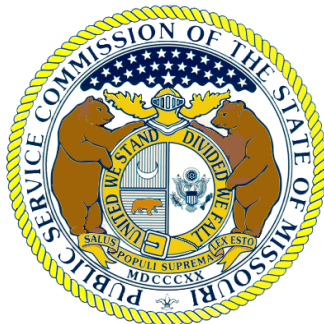
