# ORDER SETTING PROCEDURAL CONFERENCE AND EXTENDING THE TIME TO ISSUE A RECOMMENDED REPORT AND ORDER

)

On August 29, 2024,<sup>1</sup> Complainants Stan and Brenda Wilken filed a complaint with the Commission against The Empire District Electric Company d/b/a Liberty. Based on the amount in dispute alleged by Complainants, the Commission gave notice on August 29 that the matter would proceed under the Commission's Small Formal Complaint Case procedure.<sup>2</sup> Also on August 29, the Commission directed its Staff to investigate Complainants' complaint and file a report no later than October 15.

On September 30, Liberty filed a Response to Complaint. On October 11, Staff requested additional time in which to file its investigative report and the Commission granted the request the same day, giving Staff until November 27 to file its report.

On November 27, Staff filed its Staff Report and Recommendation. Having received Complainants' complaint, Liberty's answer, and Staff's investigative report, this

matter is ready to proceed. In order to discuss a procedural schedule, the Commission will set a procedural conference. The procedural conference will be conducted via WebEx video and teleconference for the convenience of the parties.

Commission Rule 20 CSR 4240-2.070(15)(G) states that after affording the parties reasonable opportunity for discovery and a fair hearing, the regulatory law judge in a small formal complaint case shall issue a recommended report and order within 100 days following the filing of the complaint. However, the time period may be extended upon a finding of good cause by the regulatory law judge. The 100-day period in this case expires on December 7, 2024.

Given Staff's request for additional time in which to complete its investigation, good cause exists to extend the time period allowed to resolve this matter. Therefore, the time period under the Commission rule to issue a recommended report and order will be extended.

(voice) or Relay Missouri at 711 before the conference. Failure to appear at the conference without being excused may result in dismissal of the complaint in accordance with Commission Rule 20 CSR 4240-2.090(5).

2. Pursuant to Commission Rule 20 CSR 4240-2.070(15)(G), issuance of a recommended report and order in this matter is extended for good cause beyond one hundred (100) days following the filing of the complaint.

3. This order is effective when issued.
