- Ameren Missouri's Commission-approved tariffs have the force and effect of law. See e.g., State ex rel. Missouri Gas Energy v. Public Service Commission, 210 S.W.3d 330, 337 (Mo. App. W.D. 2006).
- 9. The Commission is a regulatory body of limited jurisdiction having only such powers as are conferred by statute, and cannot require a refund, order damages or grant equitable relief. See e.g., *State ex. rel. GS Technologies Operating Co., Inc. v. Public Service Comm'n*, 116 S.W.3d 680, 695 (Mo. App. 2003); *American Petroleum Exchange v. Public Service Comm'n*, 172 S.W.2d 952, 956 (Mo. 1943).

WHEREFORE, the Company respectfully requests that the Commission set the matter of whether the Company has violated a statute, tariff, Commission regulation or Commission order, for hearing.
