**ORDER GRANTING EXTENSION**

On August 27, 2024,<sup>1</sup> Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) and Missouri-American Water Company (MAWC) jointly filed an application requesting that the Commission approve the sale and purchase between them of nineteen small wastewater systems. The Staff of Commission (Staff) was directed to file a recommendation no later than October 9, extended to December 9.

After discussions with Staff, Confluence Rivers and MAWC filed a supplement to the application to include specific maps and legal descriptions. Staff indicated that it needed an additional 21 days to finish its review of the supplemental information before filing its recommendation. Confluence Rivers and MAWC filed a joint motion requesting the extension. Both companies support granting the extension of time.

The Commission finds the request for an extension reasonable and will grant it.
