RESPONSE TO RECOMMENDATION FILED BY STAFF OF THE MISSOURI PUBLIC SERVICE COMMISSION

COMES NOW, the Office of Public Counsel ("OPC") submits its reply to the recommendation of the Missouri Public Service Commission. In support thereof, the OPC states as follows:

- 1. On March 31, Empire filed its proposed change to its FAC rates and true-up testimonies and tariff letters, pursuant to Commission Rule 4 CSR 240-20.090(4), and subsequently assigned Case Numbers ER-2017-0254 and EO-2017-0255 respectively.
- 2. On April 3, the Commission issued its *Notice of Application and Order Setting Time for Filings*, directing Staff to file its recommendation not later than May 1, and directing interveners to respond not later than May 11.
- 3. On May 1, Staff filed its recommendations for the Commission to approve Empire's true-up and tariff filings.
- 4. On February 28, 2017, Staff filed its sixth prudence review of cost of Empire's FAC in Case Number EO-2017-0065. OPC is pursuing an investigation of FAC costs accumulated by Empire in that case file, as that case file is the proper venue to consider the prudence of such costs.
- 5. OPC does not oppose Staff's recommendations in these case files with regard to the proposed rate; however, OPC's non-opposition to the filings in these cases is not a waiver of any right it maintains to scrutinize costs accumulated by Empire in its FAC.

6. OPC reserves the right to investigate, scrutinize, and pursue legal recourse as necessary on any question of the prudence of costs associated with Empire's past and present FAC subject to review in Case Number EO-2017-0065 and future prudence reviews.

Wherefore, the Office of Public Counsel submits its response of non-opposition to Staff's recommendations, and intends to address any prudence concerns related to Empire's FAC in EO-2017-0065.
