## ORDER DIRECTING STAFF REVIEW OF COMPLIANCE TARIFFS

On December 2, 2024,<sup>1</sup> Holtgrewe Farms Water Company, LLC and Holtgrewe Farms Sewer Company, LLC filed tariffs in the above captioned cases which were assigned Tracking Nos. JW-2025-0083 and JS-2025-0084, respectively. The tariffs bear an effective date of January 9, 2025.

The filing of the tariffs follows the filing of the *Non-Unanimous Agreement Regarding Disposition of Small Utility Company Revenue Increase Request* (Agreement) on November 25. The Agreement is still pending and will be addressed in a separate order.

The Commission will direct its Staff to review the tariffs and provide its recommendation. The Commission will also set a time for other responses.
